Generally, no permit is required but there are several areas of the State not open to dog training, it is prohibited in any area open for archery only deer hunting, and there are general open/closed seasons in the rest of the state. The boundaries and the open/closed dates are described in section 265.

Specifically, raccoon season is open from April 1 through the day preceding the opening of the raccoon season for the area (either July 1 or November 16), see Title 14 section 464.
